
Have a wonderful St. Patrick's Day and the coming of springtime. See you soon!

Eugene Hart is a retired Social Studies teacher who lives in Merced. He wrote a book entitled "**Salt and Snow, Lansford W. Hastings, the Donner Party and the Haste to Blame**." (ISBN 978-0-95592-6). The book is a **FASCINATING** discussion about how Hastings was blamed for the tragedy. It goes on to argue that Donner and Reed ignored what Hastings wrote and said. Mr. Hart self-published his book which sells it for \$40.00. Please join us to hear this amazing story. The book will be available to Genealogical Society of Stanislaus County members and guests for \$25 at the April monthly meeting!



"Salt and Snow" by Eugene Hart follows promoter and expansionist Lansford Hastings, author of the "Emigrants' Guide to Oregon and California", and his role in the opening of a new wagon route in 1846. His demanding cutoff started from Fort Bridger to the southern end of the Great Salt Lake, then west across the Salt Desert. The narrative also follows the Donner Party wagon train and the choices they made before, during, and after their unwise decision to take Hastings' new cutoff. Because of their gambles and loss of time, they were eventually trapped in the snowy hold of the Sierra Nevada mountains which led to their last resort to survive: cannibalism. Lansford Hastings and his association with the Donner Party has been unfairly criticized for decades as the main cause of the Donner Party's catastrophe. However, this book defends Hastings debunking many of the myths surrounding him and laying to rest his alleged personal ambitions and blame for the poor decisions made by the Donner Party headed by their de facto leader James Reed.



Tracking Ancestors Through Records

As genealogists we consult many types of records to try and give us a glimpse of what life might have been like for an ancestor. Some records would be considered a primary source while others would be considered secondary. Newspapers can gives us clues of where we might need to look. I was looking for a relative in New York City. I found a death date for her and then saw where her husband and child also died the same date! I thought, "What might have happened?" It was December so I thought of cold and fire. I googled the word fire and the date for New York City. I was shocked with the results! An old abandoned icehouse had been set on fire by juveniles, fire department thought the fire was out. The fire rekindled about 11:00 P.M. at night. The tenement house caught fire, people were sleeping. The year was 1946 so most people didn't have phones. The nearest firebox was a block away. My ancestor perished along with her whole family. There were 37 deaths in all. I frequently turn to newspapers to give me an initial clue to what happened to a person.

I was helping a man at our local Family History Center who was seeking information on his ancestor who had committed murder and spent time in San Quentin Prison. He knew his great grandfather had spent some time in an orphanage due to the man's father's crime. When one is searching one has to also use collateral lines. The name the man had for the wife of his ancestor didn't seem to match with the account given in the newspaper.

I started by using the digital collection of California Newspapers available online. Much was reported in San Jose Mercury and other newspapers. Information gleaned was the man had killed his married stepdaughter in what seemed like a rage of anger. Her mother's name was given as Ellen. The daughter's name was Isabella and son in law's name was Joseph Lorenzo. The newspapers also told Ellen had gone back to using her maiden name of Clark.

Searching census records I found an Ellen Clark, born in Louisiana, on the 1860 census living in San Jose. Could this be his ancestor? Checking 1850 census for Louisiana two Ellen Clark's were found. Only one fit to be the same family living in San Jose by 1860. We now had parents names for Ellen (John and Anne Clark) and sibling (John born C 1841 in Ireland) and two sisters born in Louisiana (Mary and Jane). In the newspaper it was recorded that Ellen's sister had died the Friday before her daughter's murder. When checking for an obituary I found a Jane Kerr had died on Friday before the murder...Ellen had a sister Jane. Jane was of the age to be Ellen's sister.

Newspaper also stated that Isabella's given surname has been Castro. In on line Santa Clara County records a marriage was found for Isabella Castro married to a Joseph Lorenzo. Time frame matched the length of time she had been married according to the newspaper account.

Trying to trace the family of Ellen's brother John seemed a bit easier. He appeared on the census records and had an obituary as well as two notices of his death. His obituary says he was born Co. Mayo. Ireland.

1900 census for San Jose, Santa Clara, California told us his wife had eight children with three living. John's obituary in 1918 named those three children as William, Loretta and Edward. They were all deceased. Three grandchildren were named: Edward, Stella and Bert. I concluded the children were Edward's children. It was back to census record for 1900 to look for Edward and his family who were found living in San Francisco. Now we knew the name of Edward's wife Lena. Stella and John were with the family but no Bert and additional children Edward and Harry. Some additional sleuthing led to an obituary for both Harry and Edward. Harry died while the family was still living in San Francisco and Edward died in San Jose. Bert was really Albert born C 1903. His draft registration for World War II gave his birth date. Also next of kin was his brother John. By the 1910 census Lena has a new husband George Wilson! It can be estimated that her first husband died between 1903-1907 (California death records do not begin until 1-July 1905 and we have San Francisco earthquake and fire also to contend with. We don't know when she moved with her children back to San Jose. She is listed in the City Directory of San Jose for 1907 as the widow of Edward Clark.

A search was again made through Early birth records for Santa Clara County. Births of Edward and Lena's two oldest children were found. No given name but we have to assume the children were Edward and Stella. Lena's maiden name is possibly Revees. It was spelled two different ways.

Lena Clark Wilson died in 1914 in San Jose. Newspaper records show John and Albert will have a guardian appointed. Stella must be old enough not to need one? When her grandfather died a married name of Thompkins is given for her. In searching records the correct name is Thompson!

Sadly, Stella died in 1921 leaving three daughters and a son. In 1920 her brother Albert is living in her home. Albert can be traced through the census up until 1950 (most recent census to be released). He died in 1965 in San Francisco. Stella's girls are not located on a census. Her son Claud lives with his father. Albert's obituary gives married names for three nieces (names don't match Stella's daughters). It can be speculated they were adopted or taken in my relatives? Woman with these names appear in the newspapers. One has a daughter who gets married. Grandfather Charles F Thompson is listed. Stella's husband remarried and lived until 1976. One of Stella's daughters died in 1985 and mother's last name is Clark and father's name is Thompson and her birthdate matches birth in the California index....the mystery of the Thompson girls names still needs to be solved! We know John is alive in 1942 as he also registered for the draft of World War II. Address on draft card matches address given by Albert of his next of kin. John has a wife by the name of Ruby. They both disappear from the City Directories of San Francisco. We have no death date for Ellen Clark but the newspaper of 1894 records she is near death due to a hemorrhage of her stomach.

One can find a lot of information by reading newspapers and getting birth, death and other online records. One just has to sleuth. Many answers are still needed for a complete picture of this family.



County Hall of Records








Facing I Street between 11th and 12th Streets stands the former Stanislaus County Hall of Records, a longtime focal point of downtown located on the grounds of the Courthouse. Though it can appear to be an extension of the 1960 Courthouse complex, it actually predates the current courthouse by many years and marked significant investment in the Modesto area toward the end of the Great Depression. As progress on construction of the new Stanislaus Superior Courthouse continues, the community and civic leaders have a chance to re-commit to this significant local building with planning for long-term downtown redevelopment underway.

Completed in 1939, the Stanislaus County Hall of Records was celebrated by the Modesto Bee as an "ultra modern structure built for roominess and efficiency." Completion was only made possible due to federal New Deal funds granted to the County, with federal dollars accounting for roughly one third of total construction costs. Built next to the original Victorian-era courthouse, it expanded record storage capacity and consolidated county administrative offices. When it opened to the public, the Hall of Records was home to the offices of the Board of Supervisors, Clerk, Recorder, Assessor, Auditor, Treasurer/Tax Collector, Superintendent of Schools, District Attorney, Surveyor, and Purchasing Agent. The Hall of Records was designed Russell



Guerne DeLappe (1897-1955), son of a well-established Modesto doctor who graduated from UC Berkeley and went on to become a prominent architect of civic and administrative buildings throughout California. The Hall of Records is one of only a few remaining sites in Modesto designed by DeLappe, and it has come to be lauded as the first International Style county building in the entire State. DeLappe's intent with the design was to maximize utility over ornamentation, which is line with modernist architectural design and accounts for the rather imposingly modest façade.

The Hall of Records is a physical connection to Modesto's earlier years and is an architectural jewel that adds immense value to the story of our City and County. Designed by a Modesto native, this structure deserves a new lease on life as court operations eventually consolidate and move to their new 10th Street home. With the completion of the new Stanislaus Superior Courthouse expected in the next two years, the opportunity for Modesto to preserve and repurpose this historic property in the heart of Downtown must be seriously considered as we aim to create a vibrant Downtown where Modesto's heritage meets future needs.
